The Justice Department's Deputy Attorney General Lisa Monaco [announced](#) the new initiatives in early March to supplement existing DOJ programs that already target corporate and financial misconduct. Monaco highlighted that they would create new incentives for individuals to report business misconduct and drive companies to invest further in effective compliance and reporting procedures.
